Scope


All public school systems are required to complete the 2017-2018 AQuESTT Evidence-Based Analysis (EBA) as directed by the Commissioner pursuant to Section 79-528(2) by **June 30, 2018**. The EBA is designed to provide information in support of AQuESTT classification processes, which will inform continuous improvement efforts. This collection helps public districts and schools access their EBA links in a streamlined fashion and provide feedback, if any, to NDE.

Column Headers

District ID:	ID of district
District Name:	Name of district
School ID:	ID of school building
School Name:	Name of school building
AQuESTT School Type:	Elementary, Middle, or High, based on the grade levels that are present in the school building (see “Unit of Analysis for the EBA” in the Technical Assistance Guide for more information)
Received Date:	Date when the EBA link was made available on the collection
AQuESTT EBA Link:	Opens the EBA in a new tab for district/school user to complete
Feedback Form:	Form for district/school user to send inquiries or feedback to NDE
